CLC JUDGES' TRAINING WORKSHOP - AUGUST 6, 2016 BY WILLIAM C. "BILL" ANDERSON, P.E., CHIEF JUDGE

A day-long Judges' Workshop for the Northeastern and Southeastern Regions will be held in Wilmington, Delaware and is sponsored by the Valley Forge Region. **Although conducted for those Regions, any CLC member is welcome to register.**

WHAT IS A CLC JUDGE'S TRAINING WORKSHOP?

It is seven hours of training, including classroom instruction and the actual judging of cars. **Classroom Instruction** will cover:

- Entrant and Judge responsibilities
- Judging procedures now being used
- Judging procedures that will apply in 2017 and after new 560 point system

Each participant must complete a written examination at the close of the classroom instruction.

Practice Judging will enable all participants to individually judge a representative Cadillac. Additionally, a new car will be used to illustrate the standard on which all judging is based. Critiques of the judging will occur throughout the afternoon by CLC Chief Judge Anderson.

JUDGE'S RECOGNITION PROGRAM

All participants will be awarded points as part of the CLC Judges' Recognition Program (see the CLC 2016 International Membership Directory (page 83) for details.

Those completing the course and passing the written examination will receive four points. Those completing the course will receive three points.

EYESON DESIGN 2016 STORY AND PHOTOS BY SUSAN DENCHFIELD

Several months ago we received an intriguing invitation to bring our 1949 Club Coupe to the EyesOn Design Car Show at the Edsel & Eleanor Ford House in Grosse Pointe Shores, Michigan. This is an annual Father's Day show that benefits the Detroit Institute of Ophthalmology. *Cherryette*, as we affectionately refer to her, was asked to join the class of "Streamliners by Design". Next we learned that this class had the distinction that it would be judged by "Visionaries" – visually impaired judges. Wow – but how?!! We had lots more to learn.



Since trailering is not among our favorite things to do and since actually driving is,

Randy got to work making sure that *Cherryette* was ready for the road. We decided to take a couple of days to drive out to Michigan. We pressed through huge thunderstorms on our first day and spent the night in Wilmot, Ohio at the Inn at Amish Door. (This is a jewel of a stopover on US Route 250.) The weather for the rest of the weekend was dry and lovely and hot!

We arrived in Motor City the next afternoon. We soon found our way to another annual car event taking place near-by, the Eastpointe Gratiot Cruise which might be described as a "mini" Woodward Avenue Cruise. Motor City is aptly named – people here are completely car-crazy! They LOVE their vehicles – all sorts of motorized machines with 2, 3, 4 or more wheels could be found. This affair had been going on all week with one day left for the big parade on Saturday. Returning for the parade, we were treated to even more of variety of things on wheels.

We reluctantly left the Saturday festivities and returned to the hotel to bring *Cherryette* to her full glory. Randy spent a lot of time removing bugs and remnants of the thunderstorms from her. I concentrated on the windows and interior. Many others in the parking lot were scrubbing away. A small group stopped to watch us. Randy said to one of them that he thought maybe he had met him before. The man said, "No, but you have seen me on TV!" He was Steve Plunkett of Fleetwood Country Cruize-in in London, Ontario. This turned into an enjoyable evening, swapping car stories over dinner. Steve had brought his 1934 Cadillac Model 452 Victoria. He regaled us with his plans to see and possibly bring home "The Duchess" – the 1941 Cadillac that was built for The Duke and Duchess of Windsor- Edward and Wallis.





The next morning we drove to the Edsel & Eleanor Ford House on Lake St. Clair in Grosse Pointe. Our host for our class, Bill Schultz and his wife Rita, met us and we placed *Cherryette* among the other Streamliners – all fast backs including a lovely 1939 Lincoln Zephyr, an all original 1941 Buick Sedanette, a 1936 DeSoto Airflow and lots of others, as well as the only Hoffman, an adorable little 1935 rear-engine sedan built as a prototype.





The Visionaries soon appeared with their white silk gloves, ready to judge. We watched in fascination as they carefully caressed the cars. They were accompanied by a car designer leader who gave them a great deal of information about each car.

The show program states, "Having a group of visually impaired persons judging at EyesOn Design makes our show unique and underlines for the general public what this car show is all about."

When they reached *Cherryette*, Randy "showed" them the tail light gas cap cover and had each one feel it. Their leader told them all about the P-38 fighter plane whose dual fuselage inspired the fins for this car. They asked questions and laughed at Randy's stories.

Later in the afternoon after we had made the rounds to see all the magnificent cars and the Ford mansion we returned to find *Cherryette* bedecked with a gold ribbon. Rita came running over to tell us that *Cherryette* had won the hearts of the Visionaries and had won the coveted Bridgestone Visionaries Award. We were THRILLED! The owners of the 1947 Chevrolet parked next to us confided to me that they KNEW it was all over for them when Randy opened the tail light up. The Visionaries were really taken by that feature!

We are so grateful to Richard Sills who told Bill Schultz about *Cherryette* and referred him to the CLC Potomac Region website where there are pictures of her on display at the 2016 Washington Auto Show. She is one of our very favorite cars. We have tons of memories of road trips in her packed full of kids and the dog off to Rhode Island, Detroit or Massachusetts. She got us there and back, as always, in grand style.





NEWS FROM THE CHIEF JUDGE PENSKE'S "UNFAIR ADVANTAGE" - CLC JUDGING 2017 BY WILLIAM C. "BILL" ANDERSON, P.E.

My brief foray in the Sports Car Club of America (SCCA) sports car racing from 1969 to 1972 coincided with the hey-day of the Trans-Am Series that saw all the major car manufacturers competing hammer and tong to be top dog in the unlimited cars of the Can-Am series. It was during this time period that the label "unfair advantage" was affixed to Roger Penske and the cars he fielded; cars developed and driven for the most part by Mark Donohue. In 1968, the Penske/Donohue combo won most every Trans-Am race with a Camaro. The team won the series championship again in 1972, this time with



an AMC Javelin. In 1972, with unlimited Porsche money, their Porsche 917 devastated the Can-Am competition. If that was not enough, Penske/Donohue also won the 1972 Indy 500.

All that success had many in each series complaining about Penske's "unfair advantage". I had a chance to see the "unfair advantage" in person and up close. While Penske had access to resources, back then he was not the billionaire he is today, and many of his competitors spent more money. Penske's "unfair advantage" was really simple and available to all. It combined comprehensive research, thorough preparation, across the board professional appearance – cars, personnel, and equipment – and attention-to-detail; all of which required hard work.

What does Penske's "unfair advantage" have to do with CLC judging in 2017? Penske was a careful reader of the rules in every type of race in which he competed and kept up-to-date with the many changes as they occurred. There are many changes in CLC Judging Rules that will first apply at the 2017 Grand National in Northern Virginia. Highlights of these changes are listed below.

There will be no Senior Division or Senior Classes in 2017. Cars that have received a Senior or higher award in prior events will be judged with the cars in the Primary Division using the Primary Division Classes. But, there will be Senior, Senior Wreath, and Senior Crown awards. The Primary Division remains for 1999 and older cars. (Starting in 2020, the threshold for the Primary Division will change to 20 model years old, so a 2000 Cadillac will be eligible for the Primary Division in 2020.)

The Classes used in the Touring Division will be the same as the Primary Division Classes; the current Touring Divisions Classes have been abolished for 2017. Cars 10 years old and older (2007 in 2017) can be entered in competition for Touring Awards.

The Judging Form has been increased in the number of items scored. This will permit more accurate judging. One Judging Form will be used for cars 1903 to 1966 and another for cars manufactured and assembled after 1966. The new forms have about 560 points compared with the 200-point form now in use. Although there are many more points, the scores used to award prizes will remain based on the current 100-point scale. Currently, the final score is determined by dividing the points deducted by 2 and subtracting that number from 100. With the new form, the final score will be divided by about 5.6 and then subtracting that number from 100.





The current score requirements for first, second and third place trophies in the Touring Division remain the same as existing program. However, any car meeting the score requirements will be awarded the prize earned, even if multiple cars earn the same award.

The prizes and associated scores in the Primary Division are: Senior Crown – 99 to 100 points; Senior Wreath – 97 to 98.99 points; Senior – 95 to 96.99 points; First Place – 90 to 94.99 points; Second Place – 80 to 89.99 points; Third Place – 70 to 79.99 points. A car achieving any of the Senior prizes can do so on its first showing. And, like the Touring Division, any car meeting the score requirements will be awarded the prize earned, even if multiple cars earn the same award.

A new Division, Special & Unique Cars, has been created for cars like the 1953 Cadillac Elegante and other specialty cars. I will provide a complete list of the Classes and cars included in this Division later. The important point for this Division is that the car owner/entrant must supply a complete list and description of all the unique features of the car as part of the car's entry. The owner-supplied information will supplement that contained in CLC records. These features will be used when assessing authenticity of the car's components during judging.

Modified cars will be judged. There are four classes: Hot Rod, Restomod, Mild Custom and Radical Custom. I will supply more details on the procedures used to enter, judge, and award prizes to such cars in a later column.

There is no change to Preservation Division Rules. Cars may be entered in one of the other Divisions as well as in the Preservation Division.

All cars entered in a Grand National or other CLC judged event, either judged or display only, must meet the four following rules:

- CLC Membership The car owner must be a current CLC member.
- Confirmation of Entry This document, issued by the car registrar, must be presented at registration.
- Proof of Insurance A currently valid insurance certificate or similar document establishing that the car to be shown is insured must be presented at registration.
- Fire Extinguisher A UL approved fire extinguisher, at least 2.5 pounds, must be placed alongside the left front wheel. This standardized position assures that it can be readily retrieved in an emergency.

The Judging Committee is working to complete preparation of a new CLC Judging Manual. It is planned to have this document completed and published by the late fall of 2016 so that all potential entrants can have time to prepare for the 2017 GN and Fall Festival. On Friday, June 27, 1969 at about 1 a.m., a routine police raid on the Stonewall Inn, a club in New York City known for its Gay clientele, touched off the not-so-routine Stonewall Rebellion, a series of demonstrations that are frequently cited as the start of the Gay Rights Movement in the United States and around the world. A 1969 Cadillac de Ville convertible had been parked with its top down, as usual, on the same block of the Stonewall Inn on Christopher Street -- only a stone's throw from the club's entrance -- by its owner Williamson Henderson. It was spared any damage in the chaos that followed. Once the rebellion was over, Henderson, who was at the forefront of the rebellion, was arrested and had his car impounded. The Cadillac was driven (not towed, as many think) by two plainclothes NYPD police officers to the old Sixth Precinct on Charles Street near the Hudson River in Greenwich Village. Despite the civil unrest, the car did not suffer any damage. In reality, there were no insurance claims filed by anyone for anything - not even a car scratch.





Two days later, the car was released back to Williamson Henderson, who regularly drove it down the full length of Christopher Street from Greenwich Avenue to West Street (West Side Highway) at the Hudson River in Greenwich Village, New York. Many Gay and other people would yell out – as they still do today – "The Stonewall Car"! Over the years, the Cadillac has become pretty much a parade car, getting plenty of duty in the annual NYC Gay Pride parade and other events.

In the mid-1980s, this Cadillac led a parade in NYC sponsored by GM of over 50 Cadillacs when the new-sized Coupe and Sedan de Villes were introduced. In 1994, the "Stonewall Car" led the "Spirit of Stonewall March" from the legendary Stonewall Club in Greenwich Village through some narrow streets passing the historic Washington Square Arch, with the huge Twin Towers of the World Trade Center in the distant background, all the way up Fifth Avenue with cheering spectators, into Central Park. This famous car led hundreds of thousands of gay, lesbian, bisexual and transgender (GLBT) people and their friends and supporters into the park, where hundreds of thousands had already congregated in anticipation of the biggest GLBT rally in history. Have you ever brought your car to be part of an event with a real million people? The "Stonewall Car" was the only car in the entire Central Park that glorious day, along with about 1.1 million people.

Here are some very interesting facts regarding the 1969 de Ville convertible. GM described this Cadillac as its "crown jewel". Right they were! Its weight is over 4,600 pounds (nearly 2 1/2 tons!); its length is 225 inches (nearly 19 feet long!); its width is 80 inches (over 6 1/2 feet wide); its height is 55 inches (with convertible top up); its wheelbase (the distance between axles) is 130 inches; and its massive, powerful, fuel-efficient, 375 horsepower, V-8 engine is 472 cubic inches at 4,400 rpm (revolutions per minute). It is one of the largest V-8 engines ever produced to power a passenger car! The Cadillac has the great standard-equipped power steering, power brakes, six-way power bench seat, power windows, AM/FM stereo radio, power radio antenna and, most importantly, power convertible top. The convertible top is made of white, triple-woven padded canvas with a real glass rear window. One option the car has which is rarely used is the automatic climate control system. When is the top up? Never! Not even in winter! The car is kept with the top down year-round and a custom canvas cover over it. The seating areas are white sierra ostrich-grain leather. The flooring is midnight black pile carpeting. The dashboard, door panels and rear seating area side panels have inlaid, designer grain wood. The entire "Stonewall Car" interior is original! The custom Voque tires are extra-wide whitewalls. The wheel covers are solid chrome spokes. The fuel tank capacity is a whopping 26 gallons (plus one gallon reserve). The locked gas cap is hidden behind the rear license plate ("STONEWAL").

Over 16,000 of these classic Cadillac convertible cars -- a very large number for a luxury convertible -- were produced by General Motors Corporation with Body by Fisher. The huge chrome bumpers and massive front with cast aluminum "egg-crate" grille was used as a design model for Cadillac grilles for the following two-plus decades into the 1990s. The car introduced the innovative and safety-conscious wrap around cornering lights (now found, though less grandly, on almost every car). 1969 was the year that front seat headrests (restraints) became mandatory by law. Seatbelts were now required to have a push-button open/close mechanism. The 1969 Cadillac marked the public-wanted return of the dual horizontal headlights (after four years of the vertical, un-Cadillac, 'stacked' headlamps).





In 1959, back-tracking a decade, Cadillac had the incredibly unique, "bullet" tail-lights. Ten years later, it seems that they made a point to have the 1969 tail lamps be unique. 1969 was the only year that the Cadillac had the distinctive "lantern" tail-lights. They complemented and were built-in to the slowly sweeping, modified tail fin. In fact, virtually the only major difference between the 1969 and the 1970 Cadillacs (same body, same size, same stats, etc.) were the tail-lights. The 1970 returned to the well-known, long, vertical tail-lights.

The 1969 and 1970 Cadillacs (98% identical twins) were widely described as "muscle cars with tuxedos". It is most appropriate that the 1969 is both distinctive and 'different'. The ad slogan for the 1969 Cadillac was: "The pleasure of driving the only luxury convertible built in America!" Four decades later, that horn slogan still blows true -- and with even greater significance in America's auto industry.

The most frequently asked question about the "Stonewall Car" is: "What is the mileage?" At the turn of the millennium (2000), the "SW-Car" had an original mileage of 94,169 on New Year's Day. The mileage was only

94,894 original miles three years later as of January 1, 2003, actually regarded as a very low figure considering the vehicular age. At 35 years, as of April 1, 2004, the mileage was only 94,954. In June 2005, the odometer read a low 95,169. Three years later, at the end of June 2008, the mileage read a mere 95,233 miles. In 2014, the odometer showed approximately 95,300. Since 2000, only slightly more than 1,000 miles have been added to this restricted-mileage "historical" vehicle. The engine is original and has had absolutely nothing overhauled. It even has the original glass window cleaner bottle and mount adjacent to the engine!

The "Stonewall Car", now owned by the STONEWALL Veterans' Association (SVA), has appeared in several movies, television commercials, print ads and photo shoots. It was used in the popular promotional poster for both the premiere of "Stonewall: The Play" in 1994 and "Stonewall" (the movie) in 1996. Since the "Stonewall Car" had a professional exterior restoration in mid-1999, SVA members voted unanimously to again make the car available (after a 20-year hiatus) to be 'leased' -- with SVA supervision -- for films, commercials, print ads, editorials and videos. It also gets plenty of duty in the annual NYC Gay Pride parades and other events, including this year, as the car turns 47, the Stonewall Rebellion marks its 47th anniversary and the 47th annual parade. This year's anniversary has added meaning as President Obama recently announced he was designating the area around the Stonewall Inn as the country's first national monument to GLBT rights.






